**CERTIFICATE OF AMENDMENT
TO THE
SECOND AMENDED AND RESTATED CERTIFICATE OF INCORPORATION
OF
REPUBLIC WIRELESS, INC.**

Pursuant to Section 242 of the General Corporation Law of the State of Delaware (the "DGCL"), Republic Wireless, Inc., a corporation organized and existing under the laws of the State of Delaware (the "Corporation"), does hereby certify as follows:

1. This Certificate of Amendment amends the provisions set forth below of the Second Amended and Restated Certificate of Incorporation of the Corporation filed with the Secretary of State of the State of Delaware, as previously amended and restated (the "Certificate of Incorporation").
2. The Board of Directors of the Corporation (the "Board"), acting in accordance with the provisions of Sections 141 and 242 of the DGCL, duly adopted resolutions to amend the Certificate of Incorporation as follows:
 - a. The first sentence of Article FIRST shall be amended to read as follows:

"FIRST: The name of this corporation is Relay, Inc. (the "Corporation")."

3. Pursuant to Section 242(b)(1) of the DGCL and in accordance with the Certificate of Incorporation, no meeting or vote or stockholders of the Corporation is required to adopt these amendments as they effect only a change in corporate name as described at Section 242(a)(1) of the DGCL.
4. All other provisions of the Certificate of Incorporation as currently on file with the Secretary of State of the State of Delaware shall remain in full force and effect.
5. This Certificate of Amendment, and the amendment effected hereby, shall become effective upon filing with the Secretary of State of the State of Delaware.
