

TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Release") is dated as of May 17, 2021 and delivered by WILMINGTON TRUST, NATIONAL ASSOCIATION, solely in its capacity as Collateral Agent for the benefit of the Secured Parties under the First Lien Security Agreement referred to below (in such capacity, the "Agent"), in favor of ACProducts, Inc, a Delaware corporation, Smart, LLC, an Indiana limited liability company, Master WoodCraft Cabinetry, LLC, a Texas limited liability company, acpi Wood Products, LLC, a Pennsylvania limited liability company, Cabinetworks Group Michigan, LLC (f/k/a Masco Cabinetry LLC), a Delaware limited liability company, and together with Cabinetworks Group Middlefield, LLC (f/k/a Masco Cabinetry Middlefield LLC), an Ohio limited liability company (collectively, the "Grantors" and each individually, a "Grantor"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below) or the IP Security Agreement (as defined below), as applicable.

WHEREAS, pursuant to that certain First Lien Security Agreement, dated as of February 18, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and among, ACProducts Parent, Inc., a Delaware Corporation, Cabinets 2000, LLC, a Delaware limited liability company, SCM Properties, LLC, an Indiana limited liability company, MCW Industries, L.L.C., a Texas limited liability company, the Grantors and the Agent, in order to secure payments of certain Secured Obligations, the Grantor was required to execute and deliver a First Lien Intellectual Property Security Agreement, dated as of February 18, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "IP Security Agreement") and that certain First Lien Intellectual Property Security Agreement Supplement, dated as of August 12, 2020 (the "IP Security Agreement Supplement") and pursuant thereto each Grantor assigned, pledged and granted to the Agent, for the benefit of the Secured Parties, a security interest in and to all of such Grantor's right, title and interest in and to the Collateral (as defined in the IP Security Agreement) and the Additional Collateral (as defined in the IP Security Agreement Supplement), including without limitation those (i) Trademarks listed on Schedule I hereto, (ii) Patents listed on Schedule II hereto and (iii) Copyrights listed on Schedule III hereto.

WHEREAS, pursuant to the IP Security Agreement and the IP Security Agreement Supplement, a security interest in the Trademarks was recorded with the United States Patent and Trademark Office on February 18, 2020, at Reel 6866, Frame 0176, and with the United States Patent and Trademark Office on August 12, 2020, at Reel 7020, Frame 0119.

WHEREAS, pursuant to the IP Security Agreement, a security interest in the Patents was recorded with the United States Patent and Trademark Office on February 18, 2020, at Reel 051843, Frame 0826.

WHEREAS, pursuant to the IP Security Agreement, a security interest in the Copyrights was recorded with the United States Copyright Office on February 21, 2020, at Volume 9970, Document 400.

WHEREAS, the Agent acknowledges the full payment and performance of the Secured Obligations, and as a result desires to terminate and release the entirety of any security interest it may have in the Collateral and Additional Collateral.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent, on behalf of itself and the Secured Parties, hereby fully terminates, releases, cancels and forever discharges any and all security interests it has in the Collateral and Additional Collateral, terminates the IP Security Agreement and IP Security Agreement Supplement, and retransfers, reconveys and reassigns to the Grantors, as applicable, and without representation or warranty of any kind, express or implied, free and clear of any claims by the Agent, all right, title or interest of the Agent (if any) in, to or under the Collateral and Additional Collateral. The Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release. The Agent hereby authorizes and requests that the United States Patent and Trademark Office and the Register of Copyrights note and record this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York.

It is expressly understood and agreed that Wilmington Trust, National Association is entering into this Release solely in its capacity as the Agent ON BEHALF OF ITSELF AND THE SECURED PARTIES under the Credit Agreement (as defined in the Security Agreement), and in acting hereunder, shall be entitled to all of the rights, privileges, immunities and indemnities granted to the Agent in the Credit Agreement as if such rights, privileges, immunities and indemnities were set forth herein.
