TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made in favor of R/C INTERNATIONAL, INC., a Nebraska corporation ("Grantor"), by SALEM HALIFAX CAPITAL PARTNERS, LIMITED PARTNERSHIP, in its capacity as Grantee (in such capacity, the "Grantee").

WHEREAS, Grantor has granted to Grantee, for the benefit of itself and Lenders, a lien on and security interest in all of Grantor's right, title and interest in and to the trademarks, trademark applications, trademark registrations, and any and all goodwill associated therewith set forth on Schedule 1 attached hereto (collectively, the "Trademarks") subject to the terms and conditions of the Credit and Security Agreement, dated as of August 15, 2014, among the Grantor, R/C International, Inc., Essential Products, Inc. and Lender ("Note Purchase Agreement");

WHEREAS, Grantee's lien and security interest in the Trademarks was recorded with the United States Patent and Trademark Office on August 22, 2014 at Reel/Frame 5349/0842;

WHEREAS, Grantor has paid all of its outstanding indebtedness to Grantee and the Lenders; and

WHEREAS, Grantee wishes to terminate, cancel and release all liens and security interests it has in and on the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates, cancels and releases all liens and security interests it has in and on (i) the Trademarks; (ii) all Proceeds (as such term is defined in the Note Purchase Agreement) of the Trademarks; (iii) all of the goodwill of the businesses in which the Trademarks are associated; and (iv) all causes of action, past, present and future, for infringement, misappropriation, or dilution of any of the Trademarks or unfair competition regarding the same.

Grantee shall take all further actions, and provide to Grantor all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
