TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made in favor of Marianna Industries, Inc., a Nebraska corporation ("Grantor"), by Fifth Third Bank, National Association (successor in interest to MB Financial Bank, N.A. (as successor in interest to Cole Taylor Bank) ("Lender").

WHEREAS, Grantor has granted to Lender a lien on and security interest in all of Grantor's right, title and interest in and to the trademarks, trademark applications, trademark registrations, and any and all goodwill associated therewith set forth on Schedule 1 attached hereto (collectively, the "Trademarks") subject to the terms and conditions of the Credit and Security Agreement, dated as of August 15, 2014, among the Grantor, R/C International, Inc., Essential Products, Inc. and Lender ("Credit Agreement");

WHEREAS, Lender's lien and security interest in the Trademarks was recorded with the United States Patent and Trademark Office on (i) with respect to the Trademarks not identified in subclauses (ii) through (iv), August 18, 2014 at Reel/Frame 5347/0008, (ii) with respect to the Trademark with Registration #1,899,532, August 20, 2014 at Reel/Frame 5348/0296, (iii) with respect to the Trademark with Registration #2,423,849, August 20, 2014 at Reel/Frame 5348/0285 and (iv) with respect to the Trademark with Registration #2,437,455, August 20, 2014 at Reel/Frame 5348/0268;

WHEREAS, Grantor has paid all of its outstanding indebtedness to Lender; and

WHEREAS, Lender wishes to terminate, cancel and release all liens and security interests it has in and on the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby terminates, cancels and releases all liens and security interests it has in and on (i) the Trademarks; (ii) all Proceeds (as such term is defined in the Credit Agreement) of the Trademarks; (iii) all of the goodwill of the businesses in which the Trademarks are associated; and (iv) all causes of action, past, present and future, for infringement, misappropriation, or dilution of any of the Trademarks or unfair competition regarding the same.

Lender shall take all further actions, and provide to Grantor all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
