IP ASSIGNMENT AGREEMENT

This IP Assignment (this "Assignment") is made effective on April 16, 2021 by and between Major League Lacrosse, LLC, a Delaware limited liability company ("Assignor") and Premier Lacrosse League, Inc., a Delaware corporation ("Assignee").

WHEREAS, Assignor has retained ownership of the Assignor's (i) Intellectual Property Rights (as defined in the Purchase Agreement), (ii) User Data (as defined in the Purchase Agreement), and (iii) any remaining Technology (as defined in the Purchase Agreement), set forth on Exhibit A attached hereto and incorporated herein by reference (collectively, the "Assigned IP");

WHEREAS, Assignor and Assignee are parties to the Asset Purchase Agreement, dated as of the date hereof (the "Purchase Agreement"), pursuant to which Assignor transferred, sold and conveyed to Assignee substantially all of the assets of Assignor, including the Assigned IP and the goodwill of the business symbolized thereby;

WHEREAS, Assignor now wishes to assign the Assigned IP to Assignee, and Assignee is desirous of acquiring the Assigned IP from Assignor, together with the goodwill of the business symbolized by the Marks; and

WHEREAS, the execution and delivery of this Assignment is a covenant under Section 5.04 of the Purchase Agreement.

NOW, THEREFORE, in consideration of the premises set forth herein and in the Purchase Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:


Assignor does hereby sell, assign, convey and transfer unto Assignee and its successors, assigns and legal representatives, Assignor's entire right, title and interest in and throughout the world in and to the Assigned IP (including any common law rights that may exist and are associated therewith), together with the goodwill of the business symbolized thereby and appurtenant thereto, the same to be held and enjoyed by Assignee, its successors, permitted assigns or legal representatives, together with income, royalties, damages or payments due on or after the date hereof, including, without limitation, all claims for damages or payments by reason of infringement or unauthorized use of the Assigned IP, along with the right to sue for past infringements and collect same for Assignee's sole use and enjoyment.

Assignor does hereby authorize the Director of the United States Patent & Trademark Office, and the empowered official of any country or countries foreign to the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Marks and title thereto as the property of Assignee, its successors, assigns or legal representatives in accordance with the terms of this instrument.

Assignee and Assignor also agree that multiple copies of this Assignment may be executed, each of which shall be deemed an original, and each of which shall be valid and binding upon Assignee and Assignor.


