**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Termination and Release of Intellectual Property Security Agreement (this “**Termination**”), dated as of February 22, 2021, is executed by **RISE LINE BUSINESS CREDIT, LLC**, as the lender (the “**Lender**”), under that certain Loan and Security Agreement, dated as of September 7, 2018 (as amended, supplemented and otherwise modified from time to time, the “**Loan and Security Agreement**”), in favor of **GREAT WESTERN CO., LLC.**, a Delaware limited liability company (“**Debtor**”). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Loan and Security Agreement.

RECITALS

A. Pursuant to the terms of the Loan and Security Agreement, Debtor granted to the Lender, a security interest in the Intellectual Property of the Debtor.

B. Debtor and the Lender entered into that certain Grant of Security Interest in United States Trademarks, dated as of September 7, 2018 (the “**IP Security Agreement**”), by and between Debtor and the Lender, which was recorded with the Trademark Division of the United States Patent and Trademark Office on September 25, 2018, to evidence the security interests granted under the Loan and Security Agreement and the IP Security Agreement.

C. In connection with Debtor’s repayment of all obligations outstanding under the Loan and Security Agreement, the Lender’s security interests and liens on the Collateral have terminated and been released, and

The Lender has executed this Termination in order to evidence the termination and release of its and the Lenders’ security interest in the Intellectual Property of the Debtor.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Collateral Agent hereby agrees as follows:

(a) The Lender expressly terminates and releases all of the Lender’s right, title and interest in, to and under the Intellectual Property of the Debtor (including but not limited to each of the Trademarks listed on Exhibit A hereto).


(b) The Lender represents and warrants that it has the full power and authority to execute this Termination.
