AGREEMENT

This agreement ("Agreement") is between Minnesota Public Radio ("MPR"), 480 Cedar Street, Saint Paul, MN 55101; and Lunar Inc. ("LI"), 370 Wabasha Street North, Suite 500, Saint Paul, MN 55102.

WHEREAS, MPR is the owner of:

- (i) the registered trademark LUNAR STARTUPS (No. 5519715) ("Trademark").

NOW, THEREFORE, MPR and LI hereby agree as follows:

1. Effective as of January 1, 2021, MPR hereby transfers to LI all its right, title, and interest in and to the Trademark, as well as that part of the goodwill of the business connected with the use of and symbolized by the Trademark.
2. In consideration for the rights granted in Section 1 above, LI shall pay to MPR the amount of \$0.00.
3. MPR shall have no other or further obligations of any kind with respect to the Trademark, as of January 1, 2021; provided, however, that MPR shall execute any documentation required to complete the transfer of ownership described herein.
