GRANT OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS

May 26, 2021

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, LUMBER LIQUIDATORS, INC., a Delaware corporation and LUMBER LIQUIDATORS SERVICES, LLC, a Delaware limited liability company (individually, a “Grantor,” and collectively, the “Grantors”), hereby grant to BANK OF AMERICA, N.A., as Agent for its own benefit and the benefit of the other Credit Parties (as defined in the Security Agreement referred to below), having an office at 100 Federal Street, 9th Floor, Boston, Massachusetts 02110 (the “Grantee”), a continuing security interest in the following: (i) all of such Grantor’s right, title and interest in, to and under the United States trademarks, service marks, trademark registrations, service mark registrations, trademark applications, and service mark applications set forth on Schedule A attached hereto (the foregoing, collectively, the “Marks”), (ii) all Proceeds (as such term is defined in the Security Agreement referred to below) and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

THIS GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (this “Grant”) is made to secure the satisfactory performance and payment of all the Secured Obligations of the Grantors, as such term is defined in the Third Amended and Restated Security Agreement by, among others, the Grantors, the other Grantors (as defined therein) from time to time party thereto and the Grantee, dated as of August 17, 2016 (as amended, modified, supplemented or restated hereafter, the “Security Agreement”) and as confirmed in the Confirmation, Ratification and Amendment of Ancillary Loan Documents, by and among the Loan Parties party thereto and the Grantee, dated as of March 29, 2019.


This Grant has been granted in conjunction with the security interest granted to the Grantee under the Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

This Grant and any claims, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Grant and the transactions contemplated hereby shall be governed by, and construed in accordance with, the law of the State of New York.


