

## **PARTIAL TERMINATION AND RELEASE OF LIEN IN TRADEMARKS**

**THIS PARTIAL TERMINATION AND RELEASE OF LIEN IN TRADEMARKS** (this "Release"), is dated as of May 20, 2021, and made by and among PNC Bank, National Association ("PNC") in its capacity as collateral agent under the below-defined Security Agreement, and MRI Contract Staffing, Inc., CDI Corporation, EdgeRock Technologies, LLC, Management Recruiters International, Inc., CDI-Infrastructure LLC and Browns Canyon LLC (collectively, "Grantors").

WHEREAS, pursuant to that certain Grant of Security Interest in United States Trademarks dated as of September 13, 2017 (the "Security Agreement"), made by Grantors in favor of PNC as collateral agent, a security interest was granted by Grantors to PNC, as collateral agent, in certain collateral, including the Specified IP Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on September 19, 2017, at Reel 6167 and Frame 0001;

WHEREAS, PNC now desires to terminate and release its security interest in the Specified IP Collateral defined below;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, PNC hereby states as follows:

1. Definitions. The term "Specified IP Collateral," as used herein, means all of the Grantors' right, title and interest in the trademark listed on Schedule A hereto.

2. Release of Security Interest. PNC hereby terminates, releases and discharges its security interest in the Specified IP Collateral and reassigns to the person or persons legally entitled thereto all of its right, title and interest in the Specified IP Collateral. PNC acknowledges that this Release may be filed with the United States Patent and Trademark Office or any other governmental office to evidence the partial termination and release granted by this Release.
