**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of May 27, 2021 (“Release”), is made by OFS Agency Services, LLC, as Administrative Agent (“Administrative Agent”) in favor of Wastebuilt Environmental Solutions, LLC, a Delaware limited liability company (“Pledgor”).

WHEREAS, pursuant to that certain Security Agreement dated as of October 11, 2018 (as amended, modified, restated or supplemented from time to time, the “Security Agreement”) by and among the Pledgor, Administrative Agent, and others party thereto, and the Grant of Security Interest in Trademarks dated as October 11, 2018 (“Trademark Grant”) by and among Pledge and Administrative Agent, Pledgor granted to the Administrative Agent a security interest in all of its right, title and interest in and to the Trademarks, including the trademark registrations and trademark applications listed on Schedule A attached hereto, together with all proceeds and products thereof and the goodwill of the business symbolized by the Trademarks (collectively, “Trademark Collateral”); and

WHEREAS, the Trademark Grant was recorded at the United States Patent and Trademark Office (“USPTO”) on October 16, 2018 at Reel 6457 Frame 0970.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent and Pledgor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Grant.

SECTION 2. Termination and Release. Administrative Agent, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in Pledgor’s right, title and interest in and to the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Trademark Grant;

(b) terminates the Trademark Grant; and


(c) authorizes the recordation of this Release with the USPTO at Pledgor’s expense whether by Pledgor or its agent.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
