**TRADEMARK ASSIGNMENT**

This TRADEMARK ASSIGNMENT (this "Assignment"), dated as of June 3, 2020 (the "Effective Date"), is by and between Ecolab USA Inc., a Delaware corporation ("Assignor") and ChampionX USA Inc., a Delaware corporation ("Assignee"), (each a "Party" and collectively, the "Parties"). Capitalized terms not otherwise defined in this Assignment will have the meanings ascribed to such terms in the Separation Agreement (as defined below).

**WHEREAS**, certain Affiliates of Assignor and certain Affiliates of Assignee have entered into that certain Separation and Distribution Agreement, dated as of December 18, 2019 (the "Separation Agreement"), which contemplates the assignment of the assets described herein; and

**WHEREAS**, pursuant to the Separation Agreement, Assignor has agreed to assign, transfer and convey to Assignee all of Assignor's right, title, and interest in and to the Newco Assets, including the Trademarks set forth on Schedule A hereto ( the "Assigned Trademarks").

**NOW, THEREFORE**, in consideration of the foregoing and the covenants and agreements contained in this Assignment, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Conveyance. Assignor hereby assigns, transfers and conveys to Assignee all of Assignor's right, title and interest in and to the Assigned Trademarks, including all goodwill, common law rights, rights of priority and renewals to the extent associated therewith and all rights and remedies against past, present and future infringement, dilution, misappropriation or other violation thereof, including the right to enforce the foregoing and to sue for and recover profits and damages for any and all infringements, dilutions, misappropriations or other violations thereof, whether past, present or future, to the full end of the term or terms for which said trademarks may be granted, as fully and entirely as the same would have been held and enjoyed by Assignor without this assignment.

2. Recordation; Further Assurances. Assignor and Assignee shall each take any and all additional actions as may be reasonably necessary to effect the transactions contemplated hereby, including Assignor's execution of individual assignment documentation prepared by Assignee at Assignee's expense for filing with the authorities of each individual jurisdiction. Assignor and Assignee authorize and request that the United States Patent and Trademark Office and the corresponding entities or agencies in any applicable foreign jurisdictions, record Assignee as the assignee and owner of the Assigned Trademarks (including the Trademarks set forth on Schedule A) and issue the Trademarks from any pending applications included in the Assigned Trademarks to Assignee upon issuance or registration.

3. Successors and Assigns. The provisions of this Assignment and the obligations and rights hereunder shall be binding upon, inure to the benefit of and be enforceable by (and against) the Parties and their respective successors and permitted transferees and assigns.

4. Counterparts. This Assignment may be executed in more than one counterpart, all of which shall be considered one and the same agreement, and shall become effective when one or more such counterparts have been signed by each of the Parties and delivered to each of the Parties.

5. Title and Headings. Titles and headings to sections herein are inserted for the convenience of reference only and are not intended to be a part of or to affect the meaning or interpretation of this Assignment.

6. Conflict. Nothing contained in this Assignment is intended to or shall be deemed to modify, alter, amend or otherwise change any of the rights or obligations of Assignee or Assignor under the Separation Agreement.


