FIRST AMENDMENT TO TRADEMARK SECURITY AGREEMENT

This First Amendment to Trademark Security Agreement, dated as of May 28, 2021 (this "Amendment") is among MAMMOTH HOLDINGS, LLC, a Georgia limited liability company (the "Grantor") for the benefit of MONROE CAPITAL MANAGEMENT ADVISORS, LLC, a Delaware limited liability company, as administrative agent for itself, the Lenders, and certain Affiliates of the Lenders (the "Administrative Agent").

W I T N E S S E T H:

WHEREAS, Grantor and Administrative Agent are parties to that certain Trademark Security Agreement, dated as of April 6, 2020 (as amended, restated, modified or supplemented from time to time, the "Trademark Security Agreement");

WHEREAS, Grantor, certain Affiliates of Grantor, and Administrative Agent entered into that certain Guaranty and Collateral Agreement dated as of October 16, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the "Guaranty and Collateral Agreement"; capitalized terms not otherwise defined herein having the definitions provided therefor in the Guaranty and Collateral Agreement); and

WHEREAS, Grantor and Administrative Agent have agreed to amend the Trademark Security Agreement in the manner specifically set forth herein;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereto agree as follows:

1. Amendment to the Trademark Security Agreement. Schedule 1 to the Trademark Security Agreement is hereby amended by supplementing Schedule 1 to the Trademark Security Agreement to include the information set forth on Schedule 1 attached hereto.

2. Miscellaneous.

(a) This Amendment may be executed in any number of counterparts and by the different parties to this Amendment on separate counterparts and each such counterpart will be deemed to be an original, but all such counterparts will together constitute but one and the same agreement.
