TRADEMARK ASSIGNMENT AGREEMENT

Assignee wishes to acquire Assignor's rights in the Marks, and Assignor desires to assign its rights in the Marks to Assignee.

Agreement

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby conveys, transfers, and assigns to Assignee all of Assignor's right, title, and interest of whatever kind in the Marks, together with:


- 1) the goodwill of the business relating to the product on which the Marks is used and for which it is registered,
