GRANT OF SECURITY INTEREST
TRADEMARKS

THIS GRANT OF SECURITY INTEREST, dated as of May 28, 2021, is executed by AXIOM SPACE, INC., a Delaware corporation ("Debtor"), with an address of 1290 Hercules Avenue, First Floor, Houston, Texas 77058, in favor of HORIZON TECHNOLOGY FINANCE CORPORATION, a Delaware corporation with an address of 312 Farmington Avenue, Farmington, Connecticut 06032 as collateral agent (the "Collateral Agent") on behalf of itself and the lenders party to the Agreement (as defined below) from time to time (the "Lenders").

A. Pursuant to a certain Venture Loan and Security Agreement, dated as of the date hereof (the "Agreement") by and between Debtor, the Collateral Agent and the Lenders, the Lenders have agreed to extend certain credit facilities to Debtor upon the terms and subject to the conditions set forth therein;

B. Debtor owns the registered trademarks, service marks (and applications and registrations therefor and the goodwill associated therewith), of the United States, more particularly described on Schedules 1-A and 1-B annexed hereto as part hereof (collectively, the "Trademarks");

C. Pursuant to the Agreement, Debtor has granted to the Collateral Agent on behalf of itself and the Lenders a security interest in all right, title and interest of Debtor whether presently existing or hereafter acquired, in to and under the Trademarks, together with associated goodwill, and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof for the full term of the Trademarks (the "Collateral"), to secure the prompt payment, performance and observance of the Obligations (as defined in the Agreement);

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, Debtor does hereby further grant to Collateral Agent, for the benefit of itself and the Lenders, a security interest in the Collateral to secure the prompt payment, performance and observance of the Obligations.

Debtor does hereby further acknowledge and affirm that the rights and remedies of the Collateral Agent, for the benefit of itself and the Lenders, with respect to the security interest in the Collateral granted hereby are more fully set forth in the Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
