RELEASE OF SECURITY INTEREST BY DECLARATION

I, Peter Talosig, hereby declare as follows:

I am over twenty-one years of age and am competent to make this Declaration. I serve as Senior Counsel of NCI Group, Inc. ("NCI"), and my duties include managing mergers and acquisitions and the review and title records of collateralized property, including intellectual property, and the preparation of acquisition documents and ancillary agreements and refinancing of debt documents. Based on my experience in this capacity, I have personal first-hand knowledge of the facts stated within this Declaration.

NCI is now the successor in title and current owner of certain trademark registrations that were previously owned by the company H. H. Robertson Company, a Pennsylvania corporation, having an address at Two Gateway Center, Pittsburgh, Pennsylvania 15222.

According to the records in the Assignment Division of the U.S. Patent and Trademark Office ("USPTO"), H. H. Robertson Company granted security interests to financial institutions and said security interests were recorded with the USPTO and have not been released.

Specifically, at Reel/Frame 0676/0307 in the Assignment Division records, H. H. Robertson Company granted a security interest to Equitable Bank, National Association, with an address listed at 100 South Charles Street, 7th Floor, Baltimore, MD. The security interest was recorded in the Assignment Division of the USPTO on **October 17, 1989**. The underlying

Security Interest Agreement was not available online, as the USPTO was not scanning agreements at the time of the recordal of the security interest.

In order to locate a contact for H. H. Robertson Company to inquire about a release of the security interest recorded at the above-referenced Reel and Frame, the Pennsylvania Secretary of State records were reviewed. Upon conducting the search of the records, it was found that H. H. Robertson Company is inactive and no longer in existence. Attached as **EXHIBIT 1** is a printout from the Pennsylvania Secretary of State's Office confirming the prior statement.

Similarly, the lender, Equitable Bank, N.A., was also found to be no longer in existence. According to the Maryland Secretary of State's online records, Equitable Bank, N.A. merged into MNC Financial Foundation, Inc. ("MNC") on December 6, 1990. MNC was dissolved in on December 8, 1995 according to the online records. Attached as **EXHIBIT 2** are printouts from the Secretary of State website showing the status of Equitable Bank, N.A., a note of the merger of Equitable Bank, N.A. into MNC Financial, Inc. and the search page for MNC Financial, Inc. showing that it had merged.

Based on further research, MNC Financial, Inc. merged into Maryland National Bank, which was subsequently changed its name to NationsBank in 1994, and eventually changed its name to Bank of America in 1999. See attached **EXHIBIT 3** from U.S. Bank Locations.

Our outside counsel contacted counsel for Bank of America and Bank of America has not been able to locate any records regarding the initial Credit Agreement of 1989.

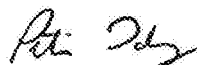
As described above, NCI has diligently tried to find the proper parties involved in the grant of the security interest and has made a good faith effort to try to obtain a release for recordal with the USPTO. However, no parties can be found that were privy to the transaction.

Further, based upon the standard operations and usual course of business in this industry, to the best of my knowledge, the loan was paid and the property was released back to the owner, H. H. Robertson Company, as the property has passed to several owners since 1989. It is not typical for several successors in title to allow an outstanding loan to remain unpaid and the security interests to remain on the title of the collateralized property.

Due to the historical date of 1989, when the security interest was recorded, and due to the lack of documentation stating otherwise, based upon the standard operations in this industry, it is our belief that the lien was removed and the property was released back to the owner, and that a release of the security interest should have been recorded with the USPTO, and we now request that the Release of Security Interest be entered.

The undersigned, being hereby warned that willful false statements and the like so made, are punishable by fine or imprisonment, or both, under 18 U.S.C. § 1001, and that such willful false statements may jeopardize the validity of the registrations that are subject to the referenced security interests, declares that he is properly authorized to execute this Declaration, and that all statements made of his own knowledge are true; and that all statements made on information and belief are believed to be true.

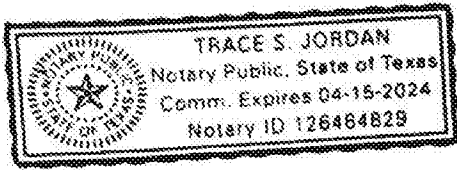

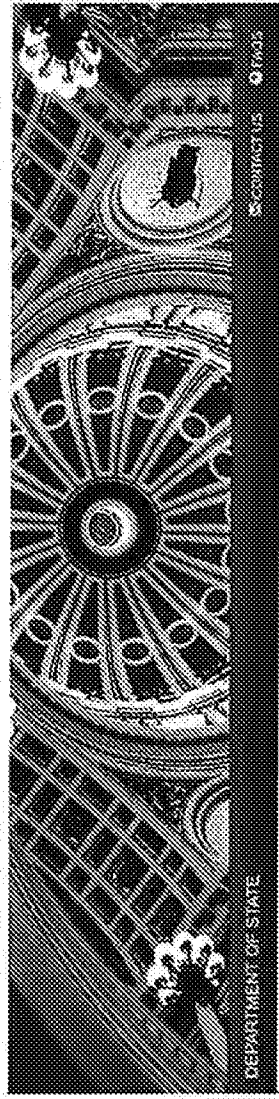

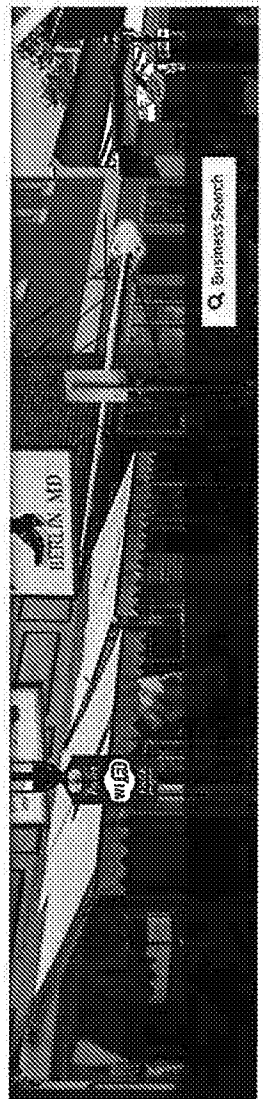
