TRADEMARK ASSIGNMENT ADDENDUM

THIS TRADEMARK ASSIGNMENT ADDENDUM (“**Assignment Addendum**”) is entered into by and between **Track & Field Co S.A.** (formerly Fratex Indústria e Comércio Ltda), a company organized under the laws of Brazil, with headquarters at Rua Visconde de Taunay, 784, Barra Funda, São Paulo/SP, CEP 01132-000 (“**Assignor**”) and **Fratex Confecção Ltda**, (formerly Track & Field Co Participações Ltda) a limited liability company organized under the laws of Brazil, with headquarters at Rua Dr. Eduardo de Souza Aranha, 387, andar 6, conj 62, edif. Juscelino Plaza, Vila Nova Conceição, São Paulo/SP, CEP 04.543-121 (“**Assignee**”) (Assignor and Assignee are collectively the “**Parties**”) and is effective as of June 24, 2020 (the “**Effective Date**”).

WHEREAS, Assignor and Assignee entered into an original Assignment on June 24, 2020 regarding ownership of the mark TF SPORTS as set forth in Schedule A hereto (the “**Original Assignment**”);

WHEREAS, Assignor and Assignee thereafter discovered a clerical error to the Original Assignment regarding the Parties names;

WHEREAS, Assignor legally changed its business name from Fratex Indústria e Comércio Ltda to Track & Field Co S.A. on February 27, 2020;

WHEREAS, Assignee legally changed its business name from Track & Field Co Participações Ltda to Fratex Confecção Ltda on February 27, 2020; and

WHEREAS, Assignor and Assignee wish to correct the clerical error relating to the Parties name as identified in the Original Assignment.

NOW, THEREFORE, Assignor and Assignee hereby expressly state and agree that the effect and intent of the Original Assignment reflected the Parties desire to assign the Trademark in the correct Parties names. With this Assignment Addendum, the Parties merely correct the clerical error and properly identify the Parties as shown above, namely, Assignor of the TF SPORTS trademark in Schedule A as Track & Field Co S.A. and Assignee as Fratex Confecção Ltda.

The Parties further confirm and agree that Assignee is a successor to Assignor’s business, or portion of the business to which the TF SPORTS mark pertains.

Except as expressly stated and updated herein, the remainder of the Original Assignment remains unchanged and in full force and effect. The Parties expressly agree the Original Assignment and the Assignment Addendum remain in full force and effect as of the Effective Date, namely, June 24, 2020.


WHEREAS, Assignor wishes to assign, and Assignee wishes to acquire, any and all rights, title and interest in the Trademark.


