The undersigned corporation, organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the “DGCL”), in accordance with the provisions of Section 264(c) of the DGCL and the provisions of Section 18-209 of the Limited Liability Company Act of the State of Delaware, DOES HEREBY CERTIFY THAT:

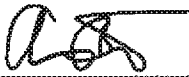
1. Complex Media, Inc. (“Complex Media”), is a corporation organized under the laws of the State of Delaware.
2. Verizon Hearst Media Partners, LLC (“VHMP”) is a limited liability company organized under the laws of the State of Delaware.
