RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (the “**Release**”), is executed by **AVIDBANK**, a California banking corporation (the “**Assignor**”), for the benefit of **YDESIGN GROUP, LLC**, a Delaware limited liability company (“**YDesign**”), and **LUMENS, LLC**, a Delaware limited liability Company (“**Lumens**”; together with YDesign, collectively, the “**Assignee**”).

WHEREAS, the Assignee and the Assignor entered into that certain Trademark Security Agreement dated as of October 30, 2020 (as the same may be amended, supplemented, or otherwise modified from time to time, the “**Security Agreement**”); and

WHEREAS, pursuant to the Security Agreement and connection with certain other loan documents, the Assignee granted the Assignor, for the benefit of the Assignor, security interests in and to certain intellectual property assets of the Assignee, including those trademarks listed in Schedule A, attached hereto, for the purpose of securing certain obligations of the Assignee to the Assignor thereunder (collectively hereinafter, the “**Intellectual Property**”); and

WHEREAS, the Assignor recorded its security interest in the Intellectual Property with the United States Patent and Trademark Office on November 2, 2020, at Reel/Frame No. 7094/0113 and Reel/Frame No. 7125/0637; and

WHEREAS, all of the indebtedness and other obligations secured by the Assignor’s security interest in the Intellectual Property have been repaid in their entirety by the Assignee, and the Assignor is therefore obligated to release its security interest in the Intellectual Property of the Assignee.

NOW, THEREFORE, for and in consideration of the premises and mutual promises in the Security Agreement and herein contained, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee and the Assignor agree as follows:

The Assignor hereby terminates and releases its security interests in the Intellectual Property, and the Assignor hereby assigns and transfers to the Assignee, without any representation, warranty, or recourse whatsoever, the Assignor’s entire right, title, and interest in and to the Intellectual Property, effective as of the date set forth above.

The Assignor hereby agrees to execute such further instruments and documents and perform such further acts as the Assignee may deem reasonably necessary to secure to the Assignee the rights herein conveyed.
