RELEASE OF TRADEMARK SECURITY AGREEMENT

This **TRADEMARK RELEASE** (the “**Release**”) is made as of June 1, 2021 (the “**Effective Date**”), executed by **WILLOW TREE AGENCY, LLC**, in its capacity as collateral agent (the “**Collateral Agent**”), in favor of the Grantor (as defined herein).

WHEREAS, pursuant to the terms and conditions of that certain Grant of Security Interest in Trademark Rights (the “**Trademark Security Agreement**”) by UNITED VETERINARY CARE VA, LLC, a Delaware limited liability company (the “**Grantor**”) in favor of the Collateral Agent, dated as of June 18, 2020, Grantor granted to Collateral Agent a continuing security interest in and to all of Grantor’s right, title and interest the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (the “**PTO**”) on June 22, 2020, at Reel 6976 and Frame 0342;

WHEREAS, the Collateral Agent wishes to release and restore all right, title and interest in, to and under the Trademark Collateral to the Grantor , including, without limitation, those set forth as set forth on Schedule A attached hereto (the “**Released Trademarks**”); and

WHEREAS, any capitalized terms used herein but not otherwise defined shall have the meanings given to them in the Trademark Security Agreement or the Security Agreement (as defined in the Trademark Security Agreement), as applicable.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent hereby (i) irrevocably releases, terminates and discharges, without any representation or warranty, any and all liens and security interests it may have in and to the Trademark Collateral, and (ii) irrevocably reassigns to the Grantor all right, title, and interest that Collateral Agent may have in, to or under any of the Trademark Collateral, and (iii) irrevocably releases and discharges Grantor from, and terminates, the Trademark Security Agreement. Collateral Agent shall duly execute, acknowledge, procure, and deliver any further documents and do such other acts, in each case, as may be reasonably requested by Grantor (and at Grantor’s expense) as may be reasonably necessary to effect, record and/or confirm the release of the security interest in, and/or any reassignment of all right, title and interest in, to or under any of, the Trademark Collateral.


Collateral Agent hereby authorizes and requests that the PTO note and record this Release.
