## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated June 1, 2021, by HANCOCK WHITNEY BANK, in its capacity as administrative agent for itself and for the other Lenders (together with its successors and permitted assigns in such capacity, "*Administrative Agent*").

### WITNESSETH:

WHEREAS, EB EMPLOYEE SOLUTIONS, LLC, a Delaware limited liability company ("*Debtor*") and Administrative Agent were parties to a certain Grant of a Security Interest in Trademarks, dated December 31, 2019, between Debtor and Administrative Agent which was recorded in the United States Patent and Trademark Office (the "*USPTO*") on December 31, 2019 at Reel 6828, Frame 0491 (the "*Agreement*"), pursuant to which Debtor granted to Administrative Agent, a continuing security interest in, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property as set forth in the Agreement (collectively, the "*Trademarks*") to secure the payment and performance of all Secured Obligations of Debtor as set out in that certain Agreement; and

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. All capitalized terms used herein but not defined shall have the meanings ascribed to them in the Agreement.
2. Administrative Agent hereby releases its continuing security interests in, and hereby reassigns, grants and conveys to Debtor, without any representation, warranty, recourse or undertaking by Administrative Agent, all of its right, title and interest, if any, in and to each trademark, trademark registration, and trademark application listed on Schedule A hereto.
3. Administrative Agent hereby authorizes Debtor, its successors, assigns and representatives to record this document at the USPTO.


