RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”), dated as of June 2, 2021 (the “Effective Date”), is made by JPMorgan Chase Bank, N.A., in its capacity as Collateral Agent (the “Agent”), in favor of the grantor parties identified on the signature page hereto (each a “Grantor” and, collectively, the “Grantors”).

WHEREAS, pursuant to that certain First Lien Guarantee and Collateral Agreement, dated as of June 1, 2015 by and among the Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), each Grantor granted to the Agent, in its capacity as Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, Concentra Integrated Services, Inc., as a Grantor executed and delivered a First Lien Copyright Security Agreement, dated as of June 1, 2015 (the “2015 Copyright Security Agreement”), for recordal with the United States Copyright Office;

WHEREAS, the 2015 Copyright Security Agreement was recorded with the United States Copyright Office on June 3, 2015 at Volume/Document 9924/999;

WHEREAS, pursuant to the Security Agreement, Concentra Inc., as a Grantor executed and delivered a First Lien Trademark Security Agreement, dated as of June 1, 2015 (the “2015 Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the 2015 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 2, 2015 at Reel/Frame 5537/0835;

WHEREAS, pursuant to the Security Agreement, U.S. HealthWorks, Inc., as a Grantor executed and delivered a First Lien Copyright Security Agreement, dated as of February 1, 2018 (the “2018 Copyright Security Agreement” and, together with the 2015 Copyright Security Agreement, the “Copyright Security Agreements”), for recordal with the United States Copyright Office;

WHEREAS, the 2018 Copyright Security Agreement was recorded with the United States Copyright Office on March 13, 2018 at Volume/Document 9955/908;

WHEREAS, pursuant to the Security Agreement, U.S. HealthWorks, Inc. and USHW of Texas, Inc., each as a Grantor executed and delivered a First Lien Trademark Security Agreement, dated as of February 1, 2018 (the “2018 Trademark Security Agreement” and, together with the 2015 Trademark Security Agreement, the “Trademark Security Agreements”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the 2018 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on March 9, 2018 at Reel/Frame 6288/0599

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement, the Copyright Security Agreements or the Trademark Security Agreements, as applicable.

2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Copyright Collateral, including the copyright registrations and applications set forth Schedule 1 attached hereto and the Trademark Collateral, including the trademark registrations and applications set forth Schedule 2 attached hereto, arising under the Security Agreement, the Copyright Security Agreements and the Trademark Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to the Copyright Collateral or Trademark Collateral under the Security Agreement, Copyright Security Agreements or the Trademark Security Agreements, as applicable, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to each Grantor.

3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Copyright Security Agreements and Trademark Security Agreements.

4. Further Assurances. The Agent agrees to take all further actions, and provide to each Grantor and its respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Grantor, at such Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.





