## ASSIGNMENT OF INTELLECTUAL PROPERTY

This Assignment of Intellectual Property (the "Assignment"), dated as of January 1, 2021, is made and entered into by and between The Marley-Wylain Company, LLC, a Delaware limited liability company with its principal place of business located at 500 Blaine Street, Michigan City, Indiana 46360 ("Assignor"), and The Marley Company LLC, a Delaware limited liability company with its principal place of business located at 999 McClintock Drive, Suite 200, Burr Ridge, Illinois 60527 ("Assignee").

**WHEREAS**, Assignor is the owner of intellectual property, including, Patents, Trademarks, Copyrights, Domain Names and Trade Secrets, that is used in, related to or otherwise necessary to operate Assignor's business (collectively, the "Intellectual Property").

WHEREAS, Assignor desires to assign to the Assignee and Assignee desires to acquire any and all rights that Assignor may have in and to the Intellectual Property; and

NOW, THEREFORE, in exchange for ten U.S. Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignment. Assignor hereby irrevocably conveys, transfers, and assigns to Assignee, and Assignee hereby accepts, all of Assignor's right, title, and interest in, to, and under the Intellectual Property, which includes, but is not limited to, the following:

(a) the patents and patent applications set forth on Schedule 1 (if any), the inventions described therein, and all issuances, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations, and renewals thereof, including all priority rights, and the right to claim priority rights and the privileges and benefits thereof, including those under the International Convention, and all other conventions, and the worldwide right to file applications for said inventions in Assignee's own name (collectively, the "Patents");

(b) trademarks, whether registered or not, trade names, trade dress and the trademark registrations and applications set forth on Schedule 2 (except for "intent to use" applications for trademarks filed pursuant to Section 1(b) of the Lanham Act, unless or until an Amendment to Allege Use or a Statement of Use under Sections 1(c) and 1(d) of the Lanham Act has been filed), together with the any common law rights related thereto and the goodwill connected with the use thereof and symbolized thereby, and all issuances, extensions, and renewals thereof (collectively the "Trademarks");

(c) copyrights and the copyrights registrations and applications set forth on Schedule 3 (if any), together with the goodwill connected with the use thereof and symbolized thereby (the "Copyrights");

(d) the internet domain names set forth on Schedule 4, together with the goodwill connected with the use thereof and symbolized thereby, (collectively, the "Domain Names");

(e) trade secrets and other confidential or non-public business information, including manufacturing processes, know-how, ideas, developments, drawings, specifications, customer and supplier lists, marketing information, sales and promotional information, business plans and other proprietary information and rights (collectively "Trade Secrets");

(f) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world (including for the avoidance of doubt, any common law rights);

(g) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(h) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, and/or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but not the obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recording and Further Assistance. Assignor authorizes the Commissioner for Patents, the Commissioner for Trademarks, the Register of Copyrights, and any other governmental officials to record and register this Assignment upon request by Assignee. Assignor further agrees that, upon request by Assignee, Assignor shall, without further consideration, execute and deliver such documents and instruments and perform such other acts as may be reasonably required in order to vest all of Assignor's right, title and interest in and to the Intellectual Property in Assignee, including the delivery to Assignee of any relevant evidence and administrative rights in Assignor's possession or control that may be reasonably required to support the foregoing.

3. Governing Law. If any provision of this Agreement shall be held by a court of competent jurisdiction to be contrary to law, the remaining provisions of this Intellectual Property Agreement shall remain in full force and effect. This Agreement shall be governed by and construed in accordance with the internal laws of the State of Delaware.

4. Successors and Assigns. This Assignment shall be binding upon and inure to the benefit of the Parties and their respective successors and assigns.

5. Counterparts. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.

6. Amendment and Modification. Assignor and Assignee hereby authorize and request their authorized agents to insert on this Assignment any further identification, including, for example, patent application numbers and filing dates, which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office or foreign jurisdictions for recordation of this document.
