FIRST SUPPLEMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

This First Supplement to Intellectual Property Security Agreement (this "Supplement") is made as of June 2, 2021 by STITCH FIX, INC., a Delaware corporation (the "Grantor") in favor of SILICON VALLEY BANK, as Administrative Agent (as defined in the Existing Grant) (the "Administrative Agent").

WHEREAS, the Grantor executed and delivered an Intellectual Property Security Agreement dated June 3, 2020 and recorded with (i) the Patent Division of the U.S. Patent and Trademark Office on June 3, 2020 at Reel 052831 and Frame 0801 and (ii) recorded with the Trademark Division of the U.S. Patent and Trademark Office on June 3, 2020 at Reel 6952 and Frame 0408 (as amended from time to time hereinafter, the "Existing Grant") in favor of the Administrative Agent, pursuant to which the Grantor's pledged, assigned and granted a security interest in certain Intellectual Property collateral (as defined therein); and

WHEREAS, the Grantor has developed additional Intellectual Property collateral and desires to hereby confirm the pledge of, and the grant of a security interest in, such additional Intellectual Property collateral in favor of the Administrative Agent.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Existing Grant.
2. Supplement to Exhibit B. Exhibit B to the Existing Grant is hereby supplemented, but not replaced, by Schedule B-1 annexed hereto.
3. Supplement to Exhibit C. Exhibit C to the Existing Grant is hereby supplemented, but not replaced, by Schedule C-1 annexed hereto.
4. Miscellaneous:
 - a. Except as provided herein, all terms and conditions of the Existing Grant remain in full force and effect. The Grantor hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.
 - b. This Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.
