or entity other than Assignee, its successors and assigns, any remedy or claim under or by reason of this instrument, or any terms, covenants or conditions hereof, and all the terms, covenants and conditions in this instrument shall be for the sole and exclusive benefit of Assignee and its successors and assigns. The parties may sign any number of copies of this Assignment. Each signed copy shall be an original, but all of them together represent the same agreement.
