TRADEMARK RELEASE AND REASSIGNMENT

This Trademark Release and Reassignment is entered into as of May 27, 2021, by **FIRST MERCHANTS BANK**, an Indiana commercial bank, as lender (the "Lender").

Stepp Equipment Company, a Delaware corporation ("Pledgor"), entered into a Grant of Security Interest in Patents and Trademark with the Lender, dated as of February 27, 2015, pursuant to which the Pledgor granted the Lender a security interest in the Trademark Collateral as defined therein, including the Trademarks referred to on Schedule I hereto (the "Trademark Agreement").

The Trademark Agreement was recorded by the Assignment Recordation Branch of the United States Patent and Trademark Office on February 27, 2015, at Reel 5468, Frame 0443.


The Pledgor has requested that the Lender release its security interest in the Trademarks.

1. As used herein, capitalized terms defined in the Trademark Agreement and not otherwise defined herein have the meanings given them in the Trademark Agreement.
2. The Lender hereby irrevocably terminates, cancels, discharges, and releases its security interest in Pledgor's right, title and interest in and to the Trademark Collateral, including without limitation the Trademarks referred to on Schedule I hereto.
3. Subject to other security interests, if any, granted by the Pledgor to other financial institutions, the Lender hereby reassigns, grants and conveys to the Pledgor, without any representation, warranty, recourse or undertaking by the Lender, all of the Lender's right, title and interest in and to the Trademark Collateral, including without limitation the Trademarks referred to on Schedule I hereto.
4. The Lender hereby irrevocably terminates the Trademark Agreement.
5. The Lender authorizes the recordation of this Release with the USPTO at Pledgor's expense whether by Pledgor or its agent.
