TRADEMARK RELEASE OF SECURITY INTEREST

THIS TRADEMARK RELEASE OF SECURITY INTEREST (this "Release") is made as of June 3, 2021, by MASSACHUSETTS CAPITAL RESOURCE COMPANY ("Lender").

WITNESSETH:

WHEREAS, Lender and SAYLENT TECHNOLOGIES, INC., a Delaware corporation ("Grantor"), were parties to those certain Intellectual Property Security Agreement, dated as of July 17, 2019 (the "IP Security Agreement"; capitalized terms used but not otherwise defined herein shall have the meanings ascribed thereto in the IP Security Agreement), pursuant to which Grantor granted a security interest to Lender in, among other things, all of Grantor's right, title and interest in, to and under the Intellectual Property Collateral, including the Trademarks set forth on Exhibit A hereto; and

WHEREAS, Grantor has requested that Lender release its security interest in the Trademarks set forth on Exhibit A and reassign the same to Grantor;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Lender hereby releases its security interest in all of Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "Trademark Collateral"):

- (a) all of Grantor's Trademarks and all IP licenses providing for the grant by or to such Grantor of any right under any Trademark, including, without limitation, those referred to on Exhibit A hereto;
- (b) all renewals and extensions of the foregoing;
- (c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
- (d) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof

2. Lender hereby reassigns, grants and conveys to Grantor, without any representation, warranty, recourse or undertaking by Lender, all of Lender's right, title and interest in, to and under the Trademark Collateral, and the goodwill of Grantor's business connected with the use of and symbolized by the Trademark Collateral.
