RELEASE OF SECURITY AGREEMENT (TRADEMARKS)

THIS RELEASE OF SECURITY AGREEMENT (TRADEMARKS) (this “Release”), dated as of June 1, 2021, is made by **LIGHTSHIP CAPITAL LLC**, as Agent (“Agent”) in favor of **MEASUR3D, LLC** (“Grantor”). Capitalized terms used but not defined herein will have the meaning given to them in the Trademark Security Agreement (whether defined directly therein or by reference to another agreement).

WHEREAS, pursuant to that certain Pledge and Security Agreement among Grantor, Agent, and certain other parties, dated as of August 31, 2016 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), Grantor executed and delivered in favor of Agent that certain Grant of Security Interest in Trademarks dated as of March 2, 2020, which was recorded with the United States Patent and Trademark Office on March 6, 2020 in its records at Reel 6899, Frame 0394 (the “Trademark Security Agreement”);

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, Grantor granted to Agent a continuing lien on and security interest (the “Security Interest”) in all of Grantor’s right, title and interest in, to and under the Trademark Collateral, including the Trademarks set forth in Schedule I; and

WHEREAS, Agent desires to release its rights and security interests in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby fully and finally (i) releases and terminates the Security Interest the Trademark Collateral, and any and all other rights it may have under the Trademark Security Agreement, and (ii) hereby re-assigns to the Grantor any right, title or interest it may have in the Trademark Collateral. Agent agrees to execute and deliver such further instruments and take or cause to be taken other or further action as Grantor may reasonably request in order to perfect, confirm or evidence such release. Grantor, and any successor to Grantor (including any person or entity hereafter holding any right, title or interest in and to the Trademark Collateral) is hereby authorized to record this release with the United States Patent and Trademark Office.
