**RELEASE OF TRADEMARK SECURITY AGREEMENT**

This Release of Trademark Security Agreement (this "Release") is made as of June 1, 2021, by WEBSTER BANK, NATIONAL ASSOCIATION, in its capacity as administrative agent for the Lenders under the Security Agreement referred to below (the "Agent") for the benefit of BENEFIT EXPRESS SERVICES, LLC, an Illinois limited liability company (the "Grantor"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement.

**WITNESSETH:**

WHEREAS, reference is made to (i) that certain Credit Agreement, dated as of February 14, 2018 (as amended, restated or otherwise modified through the date hereof (the "Credit Agreement"), by and among, among others, the Grantor and the Agent, (ii) that certain Guaranty and Security Agreement, dated as of February 14, 2018 (as amended, restated or otherwise modified through the date hereof, the "Security Agreement"), by and among, among others, the Grantor and the Agent, and (iii) that certain Trademark Security Agreement, dated as of February 14, 2018 (as amended, restated or otherwise modified through the date hereof, the "Trademark Security Agreement"), by and among, among others, the Grantor and the Agent, pursuant to which the Grantor has granted to the Agent for the benefit of the Secured Parties (as defined in the Credit Agreement) a lien on and security interest in all of the right, title and interest of the Grantor in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including the trademarks set forth on Schedule I hereto;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office (the "USPTO") on March 6, 2018 at Reel 6287 and Frame 0498; and

WHEREAS, Grantor has requested that the Agent release, and the Agent is willing to release its lien on and security interest in, and any other right, title, and interest it may have in, to and under the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent does hereby (x) terminate, release and discharge the entirety of any and all liens or security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Security Agreement or Trademark Security Agreement to the Trademark Collateral and any right, title or interest of the Agent in, to or under such Trademark Collateral shall hereby terminate, cease and become void and (y) terminate and cancel the Trademark Security Agreement. The Agent hereby assigns, transfers and conveys any and all right, title and interest of the Agent in, to and under the Trademark Collateral to the Grantor.

2. The Agent authorizes the Grantor or its designee to file this Release for recordal with the USPTO, and each of the Agent and the Grantor authorizes and requests that the USPTO record this Release.

3. This Release may be executed in any number of counterparts (including electronic transmission and facsimile counterparts), each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.


4. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.
