TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of May 28, 2021, by ARES CAPITAL CORPORATION, as Collateral Agent ("Collateral Agent"), in favor of Datum LLC, a Virginia limited liability company ("Grantor"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below) and the Security Pledge Agreement (as defined in the Security Agreement), as applicable.

WITNESSETH:

WHEREAS, in connection with the Security Pledge Agreement, Grantor executed that certain Trademark Security Agreement dated as of November 20, 2018 (the "Security Agreement"), pursuant to which Grantor granted a security interest to Collateral Agent in certain Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Collateral Agent, including the Trademarks set forth on Schedule A hereto;

WHEREAS, the Security Agreement was recorded by the United States Patent and Trademark Office on July 25, 2019, at Reel 6703, Frame 0697; and

WHEREAS, Grantor has requested that Collateral Agent release its security interest in the Trademark Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Collateral Agent, on behalf of itself and the Secured Parties, hereby terminates, cancels, releases and discharges its security interest in and Lien on all of Grantor's right, title and interest in, to and under all of the Trademarks owned by Grantor and constituting Collateral, including, without limitation, those listed on Schedule A hereto (collectively the "Trademark Collateral").


2. Collateral Agent hereby reassigns, transfers, grants and conveys to Grantor, any and all of Collateral Agent's right, title and interest in and to the Trademark Collateral.

3. This Trademark Release and Reassignment shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.
