**RELEASE OF TRADEMARK SECURITY AGREEMENT**

This Release of Trademark Security Agreement, dated as of May 6, 2021 (the “Release”), is made by Wilmington Trust, National Association (the “Agent”), in favor of Aspect Software Parent, Inc., a Delaware corporation (“Aspect”), and each of direct and indirect subsidiaries set forth on the signature pages to the Trademark Security Agreement (as defined below) (together with Aspect, each, a “Grantor” and collectively, the “Grantors”):

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of May 25, 2016 (as may have been amended, modified, restated, replaced or supplemented from time to time, the “Trademark Security Agreement”; capitalized terms used but not otherwise defined herein shall have the meaning set forth in the Trademark Security Agreement), recorded with the United States Patent and Trademark Office on June 16, 2016, at Real 5816, Frame 0289, the Grantors granted the Agent, on behalf of the Secured Parties, a security interest in and to all of their right, title and interest in all of the Grantors’ intellectual property, including the trademarks listed on Schedule I thereto (collectively, the “Trademark Collateral”); and

WHEREAS, the Grantors have requested that the Agent release its security interest in and to the Trademark Collateral.


