TO
ARTICLES OF ORGANIZATION
OF
NICOPURE LABS, LLC

FIRST: The Articles of Organization were filed on July 28, 2014 and assigned Document No. L14000118275.

SECOND: The following amendment to the Articles of Organization was adopted by the limited liability company:
