**Termination and Release of Trademark Security Agreement**

This Termination and Release of Trademark Security Agreement (this "Release") is made as of November 9, 2020, by KeyBank National Association ("Existing Lender") in favor of Accord Services, LLC, a Georgia limited liability company (the "Debtor").

W I T N E S S E T H:


