**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

Release of Security Interest in Trademarks, dated as of May 20, 2021 by PNC Bank, National Association, as Agent ("Releasor") to RGIS, LLC (the "Releasee").

**W I T N E S S E T H:**

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of October 2, 2020 (the "IP Security Agreement"), recorded in the United States Patent and Trademark Office ("USPTO") on October 6, 2020 under Reel/Frame 7071/0768, by and among Releasee, certain affiliates of Releasee (collectively, the "Grantors") and Releasor, to secure the satisfactory performance and payment in full of all the Obligations (as defined in the IP Security Agreement) of the Grantors, Releasee granted to Releasor a security interest in (i) all trademarks, service marks, trade names, domain names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, now owned or hereafter adopted or acquired, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the USPTO or any similar offices in any State of the United States or any other country or group of countries or any political subdivision thereof, and all extensions or renewals thereof, as set forth on Schedule A hereto (the "Trademarks"), (ii) all Proceeds and products of the Trademarks, (iii) the goodwill of the businesses with which the Trademarks are associated, and (iv) the rights to sue for past, present and future infringement or dilution of the Trademarks or for any injury to goodwill (collectively, the "Trademark Collateral"); and

WHEREAS, the Releasee has requested, and Releasor has agreed to execute, acknowledge and deliver, this Release of Security Interest in Trademarks to terminate the IP Security Agreement and confirm the release, relinquishment and discharge of its continuing security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, including the satisfactory performance and payment in full of all the Obligations of Grantors, the sufficiency and receipt of which are hereby acknowledged, Releasor hereby agrees as follows:


SECTION 1. Defined Terms. Unless otherwise defined herein, capitalized terms used herein shall have the meanings given to them in the IP Security Agreement.

SECTION 2. Release of Security Interest. Releasor hereby, without any representation or warranty and without any recourse to Releasor, terminates the IP Security Agreement and hereby terminates, releases, relinquishes and discharges its lien on and security interest in the Trademark Collateral and re-assigns and re-conveys to Releasee any and all right, title and interest Releasor may have in or to the Trademark Collateral.

SECTION 3. Governing Law. THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAW OF THE STATE OF NEW YORK.
