**PARTIAL RELEASE OF
SECURITY INTEREST IN TRADEMARK COLLATERAL**

THIS PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release"), is entered into as of June 4, 2021 by UBS AG, Stamford Branch, as collateral agent for the Secured Parties (as defined in the Trademark Security Agreement referred to below) (in such capacity, the "Collateral Agent") in connection with the grant of security interests in certain trademarks by Thibiant International Inc. (f/k/a Cosmetic Technologies, LLC), a company incorporated under the laws of California ("Grantor"), in favor of the Collateral Agent. Capitalized terms used and not otherwise defined herein have the meanings assigned to them in the US Pledge and Security Agreement, dated as of December 21, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time), among the Grantors party thereto and the Collateral Agent.

WITNESSETH:

WHEREAS, the Grantor entered into that certain Trademark Security Agreement (the "Trademark Security Agreement") dated as of December 21, 2018 between the Grantor and the Collateral Agent, pursuant to which the Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a continuing security interest in the Specified Trademarks Collateral (as defined below);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 26, 2018 at Reel 6509, Frame 0331;

WHEREAS, the Trademark Security Agreement erroneously included reference to the Specified Trademarks (as defined below) which are owned by Cosmetic Technologies, LLC, a Michigan limited liability company (the "Trademark Owner"), and not the Grantor;

WHEREAS, to correct the erroneous filing, at the request of the Grantor, the Collateral Agent now desires to terminate and release the entirety of its Liens on and security interests solely in the Specified Trademarks Collateral; and

WHEREAS, all rights and interests in the Specified Trademarks Collateral will revert to the Trademark Owner upon the recordation of this Release with the USPTO (as defined below).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Definitions. The term "Specified Trademarks Collateral", as used herein, means (a) Trademarks set forth in Schedule A attached hereto (the "Specified Trademarks") and (b) all proceeds of and revenues from the foregoing, including, without limitation, all proceeds of and revenues from any claim by the Trademark Owner against third parties for past, present or future infringement of the Specified Trademarks owned by the Trademark Owner.

2. Release of Security Interest. The Collateral Agent hereby (i) terminates, cancels, releases and discharges all of its Liens on and security interests in the Specified Trademarks Collateral without representation, warranty or recourse of any kind or nature, and (ii) reassigns any right, title and interest it may have, to and under the Specified Trademarks Collateral to the Trademark Owner.

3. Further Assurances. The Collateral Agent hereby authorizes the Grantor or any of its designees to record this Release with the United States Patent and Trademark Office ("USPTO") and any

other offices as may be necessary to carry out the intention of this Release, and to the extent applicable, the Collateral Agent authorizes and requests that the USPTO record this Release.

4. No waiver, Consent or Amendment. This Release shall not be construed as a release of any collateral or the termination of any guarantee under the Loan Documents, other than the release of the Specified Trademarks Collateral to the Trademark Owner.


