**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of June 9, 2021, from JPMORGAN CHASE BANK, N.A., as Collateral Agent (the "Collateral Agent") to DOUGLAS DYNAMICS HOLDINGS, INC., DOUGLAS DYNAMICS, L.L.C., DOUGLAS DYNAMICS FINANCE COMPANY and FISHER, LLC (each, a "Grantor" and collectively, the "Grantors").

WITNESSETH:

WHEREAS, pursuant to the ABL Pledge and Security Agreement dated as of May 21, 2007 (the "Security Agreement"), each Grantor granted a security interest (the "Security Interest") to the Collateral Agent for its benefit and for the benefit of the other Secured Parties in all of its right, title and interest in, to and under certain collateral, including Trademarks;

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of May 21, 2007, among the Collateral Agent and Grantors (the "Trademark Security Agreement"), each Grantor, by reference to the Security Agreement, reaffirmed its intent to grant the Security Interest to the Collateral Agent specifically in certain Collateral (as that term is defined in the Trademark Security Agreement, including the Trademarks set forth on Schedule I hereto);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on April 19, 2011 at Reel 4524 and Frame 0583.

WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its Security Interest in the Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Collateral Agent hereby states as follows:


1. Definitions. Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreement or Security Agreement.

2. Release of Security Interest. The Collateral Agent hereby terminates, releases and discharges, without recourse, representation or warranty, its Security Interest in the Collateral, and any right, title or interest of the Collateral Agent in such Collateral shall hereby cease and become void.

3. Further Assurances. The Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
