RELEASE OF SECURITY INTERESTS IN TRADEMARK COLLATERAL

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARK COLLATERAL (this "Release") is made as of this 8th day of June, 2021, by FREEPORT FINANCIAL PARTNERS LLC, as administrative agent ("Agent"), in favor of DIGITAL ARCHITECTURE, LLC, a Delaware limited liability company ("Grantor"), as follows:

WITNESSETH:

WHEREAS, pursuant to that certain Guaranty and Collateral Agreement, dated as of October 24, 2016 (as amended, modified, restated, amended and restated and/or supplemented from time to time, the "Guaranty and Collateral Agreement"), by the Grantor and the other parties party thereto in favor of the Agent, and that certain Trademark Security Agreement, dated as of April 9, 2019 (the "Trademark Security Agreement" and, collectively with the Security Agreement, the "Security Agreements") made by the Grantor in favor of the Agent, the Grantor granted a security interest in certain collateral in favor of the Agent, including the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on April 9, 2019 at Reel/Frame 6612/0978;

WHEREAS, the Grantor has satisfied and fulfilled all of its obligations to release the Agent's security interest in the Trademark Security Agreement; and

WHEREAS, the Agent now desires to terminate and release the Trademark Security Agreement and the entirety of its security interests in the Trademark Security Agreement.



The Agent hereby terminates, cancels, releases, relinquishes and discharges, in its entirety, for the benefit of Grantor, and its successors and assigns, any and all liens and security interests granted by Grantor in favor of Agent in the Trademark Collateral, including the trademarks listed on Schedule A attached hereto. The Agent hereby authorizes the Grantor and its successors and assigns or other legal representatives to file this Release with the United States Patent and Trademark Office to evidence and effectuate the release and termination of the Agent's security interest in the Trademark Collateral.
