RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of June 2, 2021 (this “Release”), is made by WELLS FARGO BANK, N.A. (as successor-in-interest to WACHOVIA BANK, NATIONAL ASSOCIATION), as Administrative Agent (in such capacity, the “Administrative Agent”), in favor of Clockwork IP, LLC (as successor-in-interest to Mister Sparky Franchising, LLC, Clockwork Home Services, Inc., One Hour Air Conditioning Franchising, LLC, Benjamin Franklin Franchising, LLC, Successware, Inc. and BuyMax, LLC) (the “Obligor”).

WHEREAS, pursuant to that certain Security Agreement, dated as of October 5, 2007 by and among the Obligor, the Administrative Agent and certain other parties thereto (the “Security Agreement”), the Obligor granted a continuing security interest in and continuing lien upon the trademarks and trademark applications listed on Schedule A attached hereto (collectively, the “Trademark Collateral”) to the Administrative Agent for the ratable benefit of the Lenders; and

WHEREAS, pursuant to the Security Agreement, the Obligor executed and delivered to the Administrative Agent, for the ratable benefit of the Lenders, the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office (“USPTO”) on October 10, 2007 at Reel/Frame 3636/0887 (the “Notice”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, on behalf of the Lenders, hereby agrees as follows:

1. Defined Terms. All capitalized terms used herein, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Notice, as applicable.

2. Release. The Administrative Agent hereby releases, discharges, terminates and cancels the continuing security interest in and continuing lien upon the Trademark Collateral, including, without limitation, the trademarks and trademark applications listed on Schedule A attached hereto, arising under the Security Agreement and the Notice. If and to the extent that the Administrative Agent has acquired any right, title or interest in, to or under the Trademark Collateral, the Administrative Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Obligor.

3. Termination. The Administrative Agent acknowledges the automatic termination and cancellation of, and hereby terminates and cancels the Notice.

4. Further Assurances. The Administrative Agent agrees to take all further actions, and provide to the Obligor and its successors, assigns or other legal representatives, at the Obligor’s sole expense, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Obligor to more fully and effectively effectuate the purposes of this Release. The Administrative Agent

hereby authorizes and requests that the Commissioner for Trademarks of the USPTO record this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.

6. Electronic Execution. This Release may be executed in one or more counterparts, and by PDF or electronic signatures.
