AFFIDAVIT TO AFFIRM THE RELEASE OF SECURITY AGREEMENT

This Affidavit to Affirm the Release of Security Agreement ("Affidavit") is effective as of June 11, 2021.

I, Laura Holland, do hereby declare as follows:

I am the CFO of Keyes Fibre Corporation, a Delaware corporation (the "Company").

1. Pursuant to that certain Credit Agreement, dated as of May 10, 2004 (the "Credit Agreement"), and that certain Trademark Security Agreement, dated as of May 10, 2004 ("Security Agreement"), Company granted a security interest to General Electric Capital Corporation (the "Administrative Agent") in the Trademark Collateral (as defined in the Security Agreement), including the trademark registrations set forth on Schedule I attached hereto (the "Trademarks").
2. The Security Agreement was recorded at the U.S. Patent and Trademark Office (the "PTO") on May 12, 2004 at Reel/Frame 2965/0332 with respect to the Trademarks.
3. To the best of my knowledge, the obligations secured under the Security Agreement were satisfied. Company repaid all its outstanding loans and other obligations in full, and the Administrative Agent, on behalf of itself and the Lenders, terminated and released its security interest in the Trademark Collateral.
4. Due to unknown reasons, a release of the Security Agreement was not filed with the PTO.
5. The undersigned, being hereby advised that willful false statement and the like so made are punishable by fine or imprisonment, or both, under 18 U. S. C. 1001, declares that the facts set forth in this Affidavit are true; all statements made of his/her own knowledge are true; and all statements made on information and belief are believed to be true.
6. The undersigned has personal knowledge of these facts and attests to their truth.
