**RELEASE OF SECURITY INTEREST  
IN TRADEMARK AND PATENT COLLATERAL**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK AND PATENT COLLATERAL (this "Release"), dated as of June 3, 2021 is made by UniCredit Bank AG, London Branch, as security agent (in such capacity, the "Security Agent"), in favor of APT Advanced Polymer Technology Corp. ("APT"), and Turfstore.com Inc. ("Turfstore") (collectively, the "Grantors"). Capitalized terms used in this Release and not herein defined shall have the meanings set forth in the Senior Facilities Agreement or the U.S. Pledge and Security Agreement, as applicable (each as defined below).

WITNESSETH:

WHEREAS, reference is made to that certain Senior Facilities Agreement dated as of April 23, 2015 (as amended by that certain Amendment Agreement Relating to Senior Facilities Agreement dated June 5, 2015 and that certain Second Amendment Agreement Relating to Senior Facilities Agreement dated August 17, 2016, as amended, restated, supplemented or otherwise modified from time to time (collectively, the "Senior Facilities Agreement") by and among the Grantors, the other Borrowers and Guarantors party thereto, the lenders parties from time to time party thereto and the Security Agent; and

WHEREAS, the Grantors are party to that certain Amended and Restated U.S. Pledge and Security Agreement dated as of January 31, 2017 (as amended, restated, supplemented or otherwise modified from time to time (the "US Pledge and Security Agreement") pursuant to which APT and Turfstore were required to execute and deliver those certain Trademark Security Agreements, dated as January 31, 2017 (the "Trademark Security Agreements"), and APT was required to execute that certain Patent Security Agreement dated as of January 31, 2017 (the "Patent Security Agreement", and, together with the Trademark Security Agreements, collectively, the "Agreements");

WHEREAS, pursuant to the Agreements, a lien on and security interest in, all of the Grantors' right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreements) and the Patent Collateral (as defined in the Patent Security Agreement), including, without limitation, the Trademark Collateral and Patent Collateral described on Annex 1 hereto, was granted by the Grantors to the Security Agent (collectively, the "Trademark and Patent Collateral");

WHEREAS, for the purpose of recording the security interest in the Trademark and Patent Collateral, the Agreements were recorded with the United States Patent and Trademark Office (the "USPTO"), as further described on Annex 1 attached hereto; and

WHEREAS, the Security Agent now desires to terminate and release the entirety of its security interest in the Trademark and Patent Collateral as described on Annex I hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Security Agent hereby agrees as follows:

1. Release of Security Interest. The Security Agent, without representation or warranty and at the Grantors' sole cost and expense, hereby (i) terminates and cancels the Agreements and (ii) terminates, cancels, releases, relinquishes and discharges, in its entirety, for the benefit of the Grantors and its successors and assigns, its lien on and security interest in and to the Trademark and Patent Collateral, including, without limitation, the Trademark and Patent Collateral described on Annex 1 hereto, and any and all right, title and interest of the Security Agent in, to and under the Trademark and Patent Collateral shall hereby terminate, cease and become void.

2. Delivery by Facsimile. Delivery of an executed signature page to this Release by facsimile or electronic (including .pdf file) transmission shall be as effective as delivery of a manually signed counterpart of this Release.

3. Further Assurances. From time to time after the date hereof, upon the Grantors' reasonable request, or upon the reasonable request of the Grantors' successors, assigns or other legal representatives, the Security Agent agrees to provide the Grantors or their successors, assigns or other legal representatives with any information and additional authorization and documentation necessary to more fully and effectively effect the release of the Security Agent's security interest in the Trademark and Property Collateral (without representation or warranty and at the Grantors' sole cost and expense).

4. Governing Law. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HERETO SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
