**CONFIRMATION OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY**

THIS AGREEMENT executed as of the 31st day of May, 2021

RECITALS:

- (a) **BAILEY METAL PRODUCTS LIMITED** (the “**Debtor**”), a corporation amalgamated pursuant to the laws of Ontario, is the owner of the trademarks and other intellectual property set forth in Exhibit "A", the registrations and applications for such trademarks and intellectual property identified therein and the underlying goodwill associated with such trademarks and intellectual property (collectively, the “**Intellectual Property**”); and
- (b) **BANK OF MONTREAL**, as administrative agent (the “**Secured Party**”), a Canadian chartered bank, has entered into an agreement with the Debtor, as reflected by: (i) a separate document entitled “General Security Agreement” dated the date hereof (as the same may be amended, modified, supplemented, extended, renewed, restated or replaced from time to time, the “**GSA**”); and (ii) the document entitled “deed of Hypothec” dated on or about the date hereof (as the same may be amended, modified, supplemented, extended, renewed, restated or replaced from time to time, the “**Hypothec**” and together with the GSA, collectively, the “**Security Agreements**”) by which the Debtor granted to the Secured Party a security interest in certain property, including the Intellectual Property, in consideration of the provision of certain credit facilities to the Debtor.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are acknowledged, and in accordance with the terms and obligations set forth in the Security Agreements, the Debtor hereby confirms the grant to the Secured Party of a security interest in and to the Intellectual Property.
