RELEASE OF TRADEMARK SECURITY AGREEMENT

June 10, 2021

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of June 18, 2019 and attached hereto as Exhibit A (the "Agreement"), the Pledgor party thereto, Zego Inc., a Delaware corporation (the "Releasee") created in favor of TC Lending, LLC, a Delaware limited liability company (in such capacity, together with its successors and assigns, "Releasor"), as collateral agent for the secured parties under that certain Credit Agreement, dated as of July 28, 2017, as amended through the date hereof, a security interest in all of the Trademark Collateral (as defined in the Agreement);

WHEREAS, the Agreement was recorded with the United States Patent and Trademark Office on July ____, 2019, at Reel ____, Frame ____; and

WHEREAS, Releasee has requested and Releasor has agreed to provide this Release of Trademark Security Agreement (this "Release") to confirm the release, relinquishment and discharge of Releasor's security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given or referenced to them in the Agreement.

2. Release of Security Interest. Releasor hereby, on behalf of itself and the Secured Parties, (i) terminates, releases, cancels, relinquishes and discharges its and the Secured Parties' Security Interest in the Trademark Collateral, including without limitation, all of Releasees' right, title and interest in and to the Trademark Collateral listed on Schedule I to the Agreement, together with any and all (a) rights and privileges arising under applicable Legal Requirements with respect to the use or ownership of any of the foregoing, (b) goodwill associated therewith, (c) continuations, extensions, and renewals thereof and amendments thereto, (d) Proceeds of any and all of the foregoing and (e) Exclusive Licenses in or to Trademarks, as well as any other lien or security interest Releasor or any Secured Party may have in the Trademark Collateral or any other collateral of Releasee under the Agreement, (ii) terminates the Agreement and (iii) hereby reassigns any and all such right, title and interest that the Releasor or any Secured Party may have in, to or under the Trademark Collateral, together with the goodwill of the business symbolized thereby, to each of the Pledgors.

3. Authorization. Releasor hereby authorizes Releasee or Releasee's agent to record this Release with the United States Patent and Trademark Office.
