ASSIGNMENT OF TRADEMARK RIGHTS

THIS Assignment Agreement (hereinafter "AGREEMENT") is effective as of the 5th day of March, 2019 (hereinafter the "EFFECTIVE DATE").

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the complete receipt and sufficiency of which are hereby acknowledged, ASSIGNOR agrees to assign, and hereby does assign, as of the EFFECTIVE DATE, all right, title, and interest in and to the MARK, together with all of the goodwill of the business

symbolized thereby, and including the right by ASSIGNEE to sue for and keep for itself and its successors and assigns any recovery for all past infringements of said MARK.

ASSIGNOR represents that as of the EFFECTIVE DATE, ASSIGNOR is the owner of all right, title, and interest in and to the MARK, and that ASSIGNOR has not assigned, transferred, licensed or encumbered ASSIGNOR'S rights therein, and that ASSIGNOR will not hereafter assign or attempt to assign any rights therein, or take any other action inconsistent with this AGREEMENT.


