RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**, dated as of June 15, 2021 (this "Release"), is made by BNP PARIBAS, in its capacity as Administrative Agent for the Lender Parties (together with its successors and permitted assigns in such capacity, the "Administrative Agent"), in favor of OLDE THOMPSON, LLC, a California limited liability company and GEL SPICE CO., INC., a New Jersey corporation (each a "Grantor" and collectively, the "Grantors"). Capitalized terms used but not otherwise defined herein have the meaning given to them in the Pledge and Security Agreement.

WITNESSETH

WHEREAS, Grantors and the Administrative Agent are parties to that certain Pledge and Security Agreement, dated as of July 21, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Pledge and Security Agreement");

WHEREAS, pursuant to the Pledge and Security Agreement, the Grantors executed the Trademark Security Agreement, dated as of July 21, 2020 (the "Agreement") and recorded with the U.S. Patent and Trademark Office on July 21, 2020 at Reel/Frame Nos. 7003/0381 and 7003/0418, pursuant to which the Grantors pledged and granted to the Administrative Agent for the benefit of the Lender Parties a continuing security interest in all of Grantors' right, title and interest in and to the Trademark Collateral (as defined in the Agreement).


WHEREAS, the Grantors have requested that the Administrative Agent release its security interest in all right, title and interest in, to and under all of the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Administrative Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under all of the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Administrative Agent may have obtained in, to and under the Trademark Collateral under the Pledge and Security Agreement and the Agreement.


