
WHEREAS, Assignee desires to purchase and acquire all right, title and interest in and to the Assigned Mark, together with the goodwill associated therewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:


