**Under Section 242 of the Delaware Corporation Law**

Pursuant to Section 242 of the General Corporation Law of the State of Delaware, the undersigned, being the President and Chief Executive Officer of CCC Information Services Inc., a Delaware corporation (the "Corporation"), does hereby certify the following:

**FIRST:** The name of the Corporation is CCC Information Services Inc.

**SECOND:** The original Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on December 2, 1982, under the corporate name of Certified Collateral Corporation. A Restated Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on May 14, 1987, under the corporate name of CCC Information Services Inc. A Second Amended and Restated Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on December 20, 2012.

**THIRD:** The Second Amended and Restated Certificate of Incorporation of the Corporation is hereby amended to effect a change in the first article thereof, relating to the name of the Corporation. Accordingly, the first article of the Second Amended and Restated Certificate of Incorporation shall be amended to read in its entirety as follows:

**FIRST:** The name of the Corporation is CCC Intelligent Solutions Inc. (the "Corporation")."

**FOURTH:** The amendment to the Second Amended and Restated Certificate of Incorporation of the Corporation effected hereby was approved by the Board of Directors of the Corporation, and by written consent of the sole stockholder of the Corporation.
