FIRST AMENDED INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This FIRST AMENDED INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT ("FIRST AMENDMENT") is entered into and made effective as of May 26, 2021, by and among Hatteras/Cabo Yachts, LLC, a Delaware limited liability company ("HCY"), and White River Marine Group, LLC, a Missouri limited liability company ("Company"), and together with HCY, the "Parties", and each individually, a "Party").

WHEREAS, the Parties entered into an AMENDED INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT effective May 26, 2021, which transferred certain intellectual property including trademarks from HCY to Company;

WHEREAS, by the INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT HCY intended to transfer to Company, and the Company expected to receive, the goodwill associated with each trademark identified in the INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT.


NOW, THEREFORE, in consideration of \$1 (one dollar) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:


1. The parties confirm their intent that the INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT transfer the good will associated with each trademark identified in the INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT.

To the extent that the INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT was ineffective to do so, by this FIRST AMENDMENT HCY hereby sells, assigns and transfers to the Company all rights in the trademarks identified in the INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT, including the entire good will associated therewith.
