RELEASE OF SECURITY INTEREST IN INTELLECUAL PROPERTY

This Release of Security Interest in Intellectual Property is made as of June 15, 2021, by **VENTURE LENDING & LEASING VI, INC.** (“VLL6”) and **VENTURE LENDING & LEASING VII, INC.** (“VLL7”), both Maryland corporations (sometimes referred to herein individually and together as “**Secured Party**”) in favor of **STITCH FIX, INC.**, a Delaware corporation (“**Grantor**”) (formerly known as Rack Habit Inc.) with its principal place of business located at 1 Montgomery Street, Suite 1500, San Francisco, CA 94104.

Recital

WHEREAS, Grantor granted to Secured Party a security interest in the trademarks described on Exhibit A attached hereto (the “**Intellectual Property**”) under an Intellectual Property Security Agreement dated as of May 15, 2013 (the “**IP Security Agreement**”) and recorded with the U.S. Patent and Trademark Office as set forth on Exhibit A.

WHEREAS, Grantor has requested and Secured Party has agreed to release its security interest in the Intellectual Property and terminate the IP Security Agreement.


Agreement

Now, therefore, Secured Party agrees that it terminates and releases its security interest in the Intellectual Property, terminates the IP Security Agreement, and reassigns to Grantor, without warranty or recourse, all interest of Secured Party in the Intellectual Property.


