RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of May 28, 2021 (“Effective Date”) by and between Jefferies Finance LLC (“Collateral Agent”), and Quorum Health Resources, LLC, a Delaware limited liability company (“Grantor”).

WHEREAS, pursuant to that certain Trademark Security Agreement by Grantor, Blue Island Hospital Company, LLC, a Delaware limited liability company, and QHCCS, LLC, a Delaware limited liability company in favor of Collateral Agent dated July 7, 2020 (the “Trademark Security Agreement”), Grantor granted to Collateral Agent a continuing security interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, the Trademarks (as defined in the Trademark Security Agreement) listed on Schedule 1 attached hereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Trademark Office on July 7, 2021 at Reel 6991, Frame 0941.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby terminates, cancels and releases any and all security interests granted by the Trademark Security Agreement against the Trademark Collateral listed on Schedule 1 attached hereto.

Collateral Agent shall take all further actions, and provide to Grantor, Grantor’s successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release. Except as otherwise set forth herein, the Trademark Security Agreement shall remain in full force and effect after giving effect to this Release.
