ARTICLE I

The name of this corporation is TerViva, Inc. (the "Corporation").

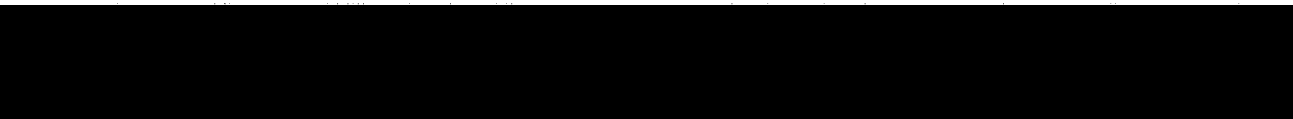
ARTICLE II
