INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this "Agreement"), is made as of April 1, 2021 (the "Effective Date"), by and between Forcepoint Federal Holdings LLC, a Delaware limited liability company (formerly known as Forcepoint, LLC, "Assignor") and Forcepoint LLC, a Delaware limited liability company (formerly known as Websense, LLC, "Assignee"). Assignor and Assignee are referred to herein individually as a "party" and collectively as the "parties."

WHEREAS, in connection with the transactions contemplated by that certain Asset Transfer Agreement, entered into on even date herewith, by and among Assignee and Assignor (the "Transfer Agreement"), the parties desire to execute and deliver this Agreement for the purpose of effecting the assignment by Assignor of all of its right, title and interest in and to any Intellectual Property Rights in the Territory (defined below) that are (i) primarily used in the operation of the Business and/or (ii) primarily used in the design, development, promotion, marketing, support or sale of the Forcepoint Products (defined below), including without limitation, the Patents, Marks, Copyrights and Domain Names (as those terms are defined below) set forth on Exhibit A attached hereto (all of the foregoing, collectively, the "Assigned IP Rights", which, for purposes of clarity, shall expressly exclude the Intellectual Property Rights set forth on Exhibit B attached hereto (the "Excluded IP")) to Assignee as further described herein.

NOW THEREFORE, for other good and valuable consideration, including one dollar (\$1.00) and such other consideration reflected in the Transfer Agreement, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the parties agree as follows:

- 1. <u>Definitions</u>. As used in this Agreement, the following terms have the meanings set forth below.
- "Intellectual Property Rights" means any and all intellectual property (a) rights in the Territory, whether registered or not, including without limitation all (i) patents (including all reissues, divisionals, provisionals, continuations and continuations-in-part, reexaminations, renewals, substitutions and extensions thereof), patent applications and other patent rights and any other governmental authority-issued indicia of invention ownership (including inventor's certificates, petty patents and patent utility models) (collectively, "Patents", including but not limited to, those described in Exhibit A), (ii) copyrights in works of authorship of any type and all rights, title and interests in all copyrights, copyright registrations and applications for copyright registration, certificates of copyright and copyrighted interests throughout the Territory (collectively, "Copyrights); (iii) trade names, trademarks and service marks, logos, corporate names, trade dress and similar rights, and all registrations and applications (including intent to use applications) to register any of the foregoing and all goodwill associated therewith throughout the Territory (collectively, "Marks", including but not limited to, those described in Exhibit A); (iv) internet domain names and internet domain name registrations, and other internet addresses or identifiers (collectively, "Domain Names", including but not limited to, those described in Exhibit A); (v) rights, title and interests in all

trade secrets and trade secret rights arising under common law, state law, federal law or laws of foreign countries, in each case to the extent any of the foregoing derives economic value (actual or potential) from not being generally known to other Persons who can obtain economic value from its disclosure or use; and (vi) moral rights, publicity rights and any other intellectual property or proprietary rights in any other technology of any kind or nature, in each case, within the Territory including but not limited to design registrations, URLs, and doing business designations, designs, software, website, webpages, data and database rights and registrations and applications for registration thereof, including moral rights of authors; inventions, invention disclosures, statutory invention registrations, trade secrets and confidential business information, know-how, manufacturing and product processes and techniques, algorithms, codes, research and development information, financial, marketing and business data, pricing and cost information, business and marketing plans and customer and supplier information, and any other intangible or beneficial rights, whether patentable or non-patentable, whether copyrightable or non-copyrightable and whether or not reduced to practice.

- (b) "Business" has the meaning ascribed thereto in the Transfer Agreement.
- (c) "<u>Forcepoint Products</u>" means those products, goods and services set forth on <u>Exhibit C</u>.
- (d) "<u>Person</u>" means an individual, group, corporation, partnership, limited liability company, association, company, joint venture, estate, trust, association, or other entity or organization of any kind or nature, including any governmental authority.
 - (e) "Territory" means all of the geographic areas of the world.
- Assignment. Subject to the terms and conditions of this Agreement, Assignor hereby irrevocably and unconditionally conveys and assigns to Assignee (a) all of Assignor's right, title, and interest in the Territory in and to the Assigned IP Rights, same to be held by Assignee for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Agreement had not been made; and (b) all of Assignor's rights to income, royalties, and license fees deriving from the Assigned IP Rights in the Territory, all of Assignor's claims for damages by reason of past, present and future infringements of the Assigned IP Rights or injury to the goodwill associated with the Assigned IP Rights in the Territory, and all of Assignor's rights to sue for and collect such damages in the Territory, as permitted under the applicable laws for any jurisdiction or country in which such claims may be asserted in the Territory, for the use and benefit of Assignee and its successors, assigns and other legal representatives (collectively, the "Assignment").
 - 3. Effective Time. This Agreement shall be effective upon the Effective Date.
- 4. <u>Further Assurances</u>. Assignor shall use commercially reasonable efforts: (i) to consummate, confirm, or evidence the transfer to Assignee of the Assigned IP Rights; and (ii) to assist Assignee in preserving or perfecting its rights in the Assigned IP Rights.

5. <u>Miscellaneous</u>.

- (a) This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.
- (b) This Agreement will be construed under and in accordance with, and governed in all respects by, the laws of the State of Delaware, without regard to its conflict of law principles.
- (c) This Agreement may be amended or modified only by a written instrument executed by all of the parties.
- (d) If any term, provision, covenant or restriction of this Agreement is held by a court of competent jurisdiction or other authority to be invalid, void, unenforceable or against its regulatory policy, such determination shall not affect the enforceability of any others or the remainder of this Agreement.
- (e) This Agreement may be executed in any number of counterparts (including by facsimile or electronic signature), each of which will be deemed an original as against the party whose signature appears thereon, but all of which taken together will constitute but one and the same instrument.
- (f) This Agreement, together with the IP Agreement, contains the entire understanding of the parties with respect to the subject matter of this Agreement. All other express or implied agreements and understandings, either oral or written, made on or before the Effective Date, are expressly superseded by this Agreement.
